What is the overall deductible?	In-network: \$2,750 Individual Coverage; \$3,000/\$5,600 Family	Generally, you must pay all of the costs from providers up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> , each family member must meet thier own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
Are there services covered before you meet your deductible? Yes. Preventive care and insulin are covered before you meet your deductible.		This <u>plan</u> covers some items and services even if you haven't yet met the <u>deductible</u> amount. But a <u>copayment</u> or <u>coinsurance</u> may apply. For example, this <u>plan</u> covers certain <u>preventive services</u> without <u>cost sharing</u> and before you meet your <u>deductible</u> . What is not included in the <u>out-of-pocket limit</u> ?	Premiums, balance billed charges, costs of health care and drugs this plan doesn't cover, and out-of-network copayments.	Even though you pay these expenses, they don't count toward the out-of-pocket limit.
Will you pay less if you use a <u>network provider</u> ?	Yes. See <u>www.guidestonehealth.org</u> or call 1-855- 497-1230 for a list of participating providers. ## Does this plan provide Minimum Essential Coverage? Yes
